

## A ADDITIONAL USE CASES

We describe two additional use cases that demonstrate the utility of *F2Q*: eviction and small claims.

### A.1 Eviction

The eviction use case aims to help a client coming to the help center deal with their eviction cases (as either a tenant or a landlord), such as:

- Stopping being evicted by a landlord;
- Getting their deposit back after being evicted;
- Evicting someone from their house;
- Dealing with the possessions of a tenant who has been evicted;
- Dealing with eviction-related court papers;
- Getting help with an upcoming hearing.

Fig. 5 (left) shows the complete flowchart designed using the designer tool based on input provided by a collaborating legal expert; it contains 10 scenarios after the initial question.

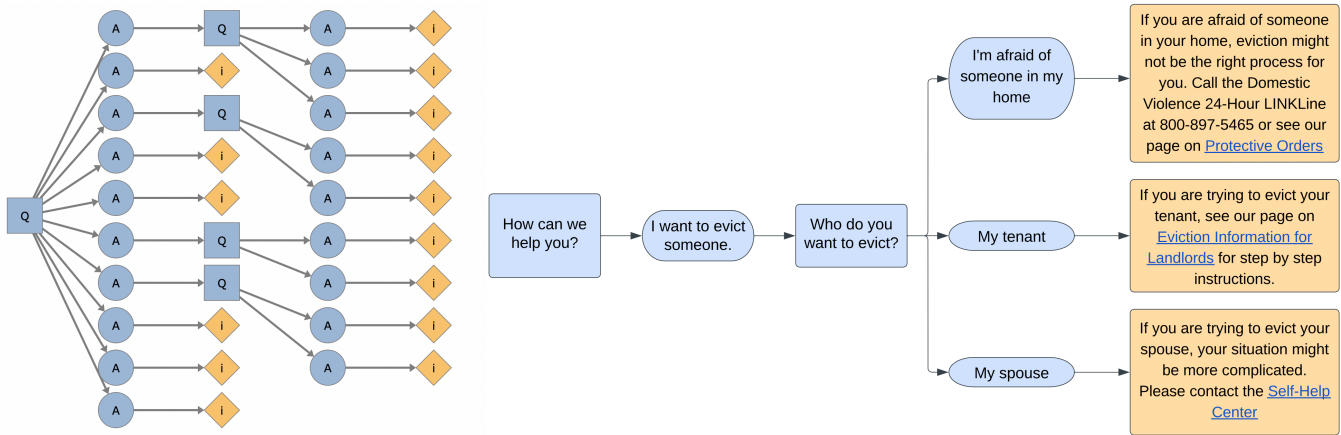


Figure 5: Eviction case: the flowchart design (left) and a snapshot of the questionnaire (right).

Fig. 5 (right) demonstrates a snapshot (a subgraph) of the flowchart with contexts, starting with the question “How can we help you?”. If a client selects the answer “I want to evict someone”, they will be asked to select who they want to evict. Based on the client’s answer, the system will provide corresponding information for what they could do next. For example, if the client wants to evict a tenant, a link to the page “Eviction Information for Landlords” will be provided for further instructions. In this way, a client will be able to quickly get the information they need, instead of sorting through an overwhelming amount of information available on a typical legal help website.

Fig. 6 (left) shows the client-facing interactive eviction questionnaire. It starts with a top-level question of the flowchart, and shows a snapshot of 7 of the 10 questions.

### A.2 Small Claims

The small claims use case is related to filing small claims. A small claims court is a special court where disputes are resolved quickly and inexpensively, as long as the claim is within a specific limit. In the State of Utah, the limit is \$15,000 or less. This small claims questionnaire designed by a legal expert helps a client figure out, for example,

- Whether they should file a small claim or not;
- How they can file a small claim;
- Who they could sue using the small claims;
- How to deal with an online dispute resolution (ODR).

Fig. 7 (left) shows the flowchart designed using *F2Q*. Fig. 7 (right) displays a case where the system provides information depending on whether the client wants to sue a business or not. Fig. 6 (right) shows the corresponding top-level client-facing questionnaire according to the flowchart.

## B COMPLETE QUESTIONNAIRE DESIGN

For completeness, we present the questionnaire design of the four use cases in their entirety using *F2Q*. Fig. 8, Fig. 9, Fig. 10, and Fig. 11 are flowcharts with context associated with eviction, debt collection, small claims, and protection cases, respectively. They are based on input from a collaborating legal expert.

## Legal Help - Eviction

How can we help you?

I want to evict someone.

What do I put in the eviction notice? I just want them out. / Which eviction notice do I use?

I just got these papers, what do I do? / What do I do with my eviction papers? / How do I file an answer?

I got an eviction notice. The rental had mold and they never made repairs. / I got an eviction notice but am withholding rent.

I tried to pay but my landlord would not take my rent. / The landlord wouldn't accept my rent.

How do I get my stuff back? / I need my stuff back / I was evicted and my landlord won't give me my stuff back

## Legal Help - Small Claims

How can we help you?

I need to file a complaint against someone / How do I sue someone? / I got ripped off and need help / I need to sue someone / I want to sue someone for \$20,000. / I want to sue someone for more than the limit in small claims / Should I sue in small claims or district court? / Can I sue in small claims court to get my \_\_\_ back?

Where do I file my case? / I bought things online and never got them. Where do I sue? / Where do I file? / Where do I file if I am suing a business with multiple locations? / Who do I serve if I am suing a business?

Should I sue the company or the person I dealt with?

I want to sue the government and a government employee.

Do I have to do ODR? / Do I have to participate in ODR? / Can I get out of ODR? / I want to opt out of ODR/ Can I opt out of ODR?

I did not receive a court notice / I could not connect for the hearing.

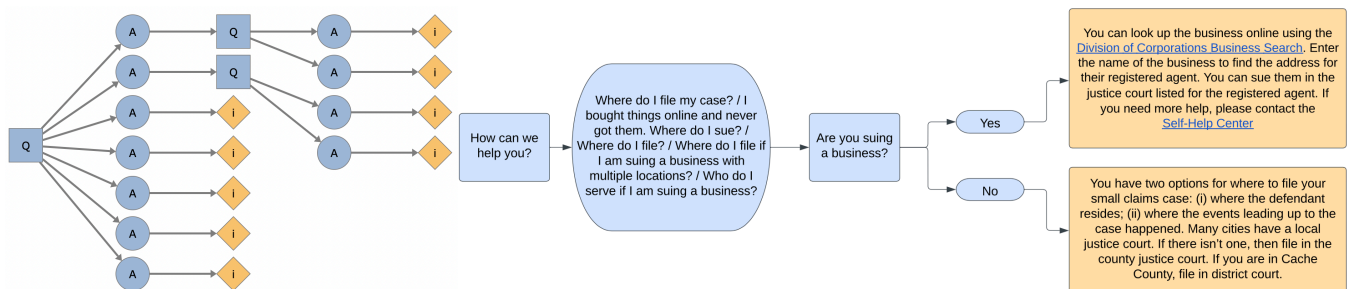


Figure 7: Small claims case: the flowchart design (left) and a snapshot of the questionnaire (right).

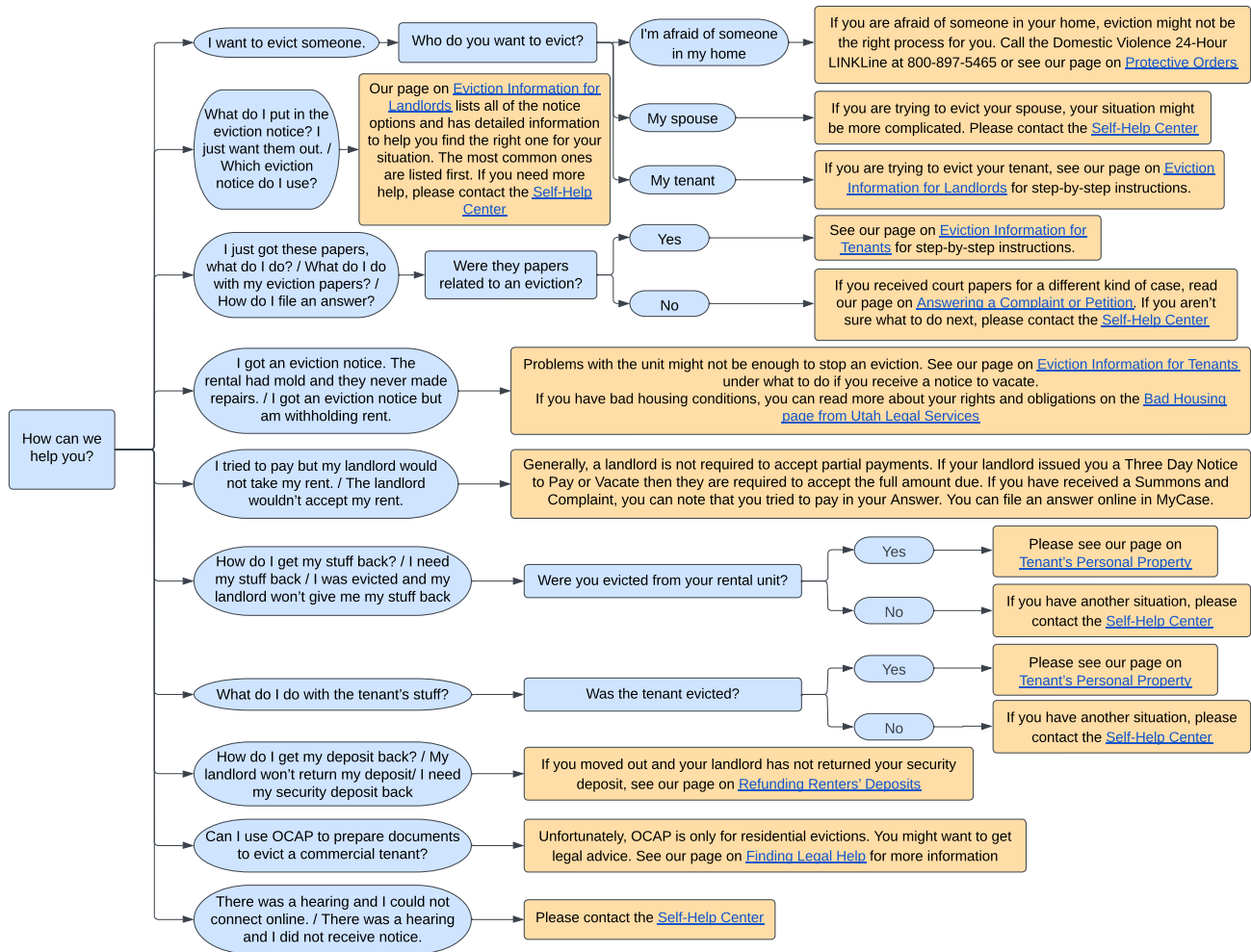


Figure 8: The flowchart with context for the eviction questionnaire.

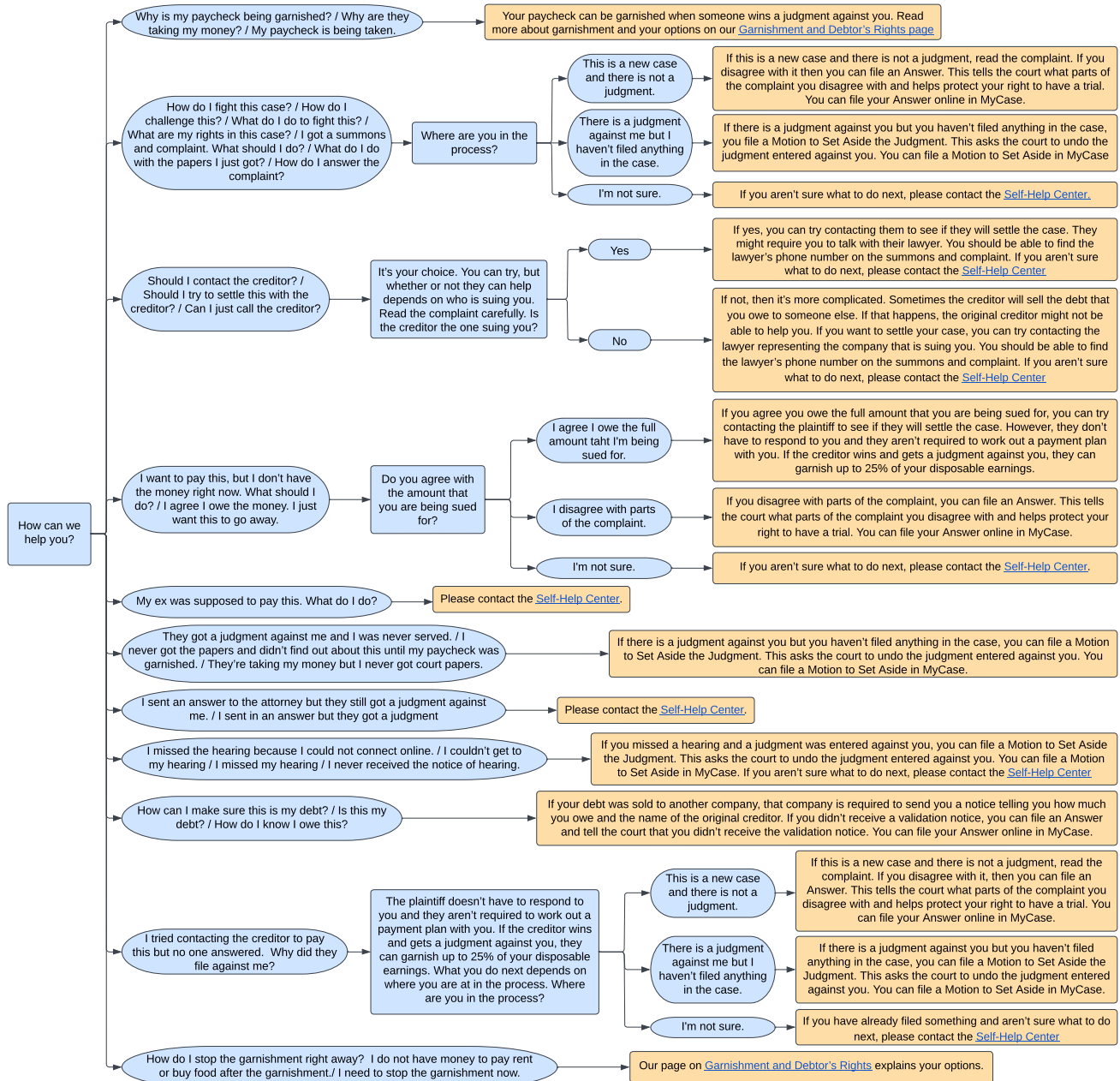


Figure 9: The flowchart with context for the debt collection questionnaire.

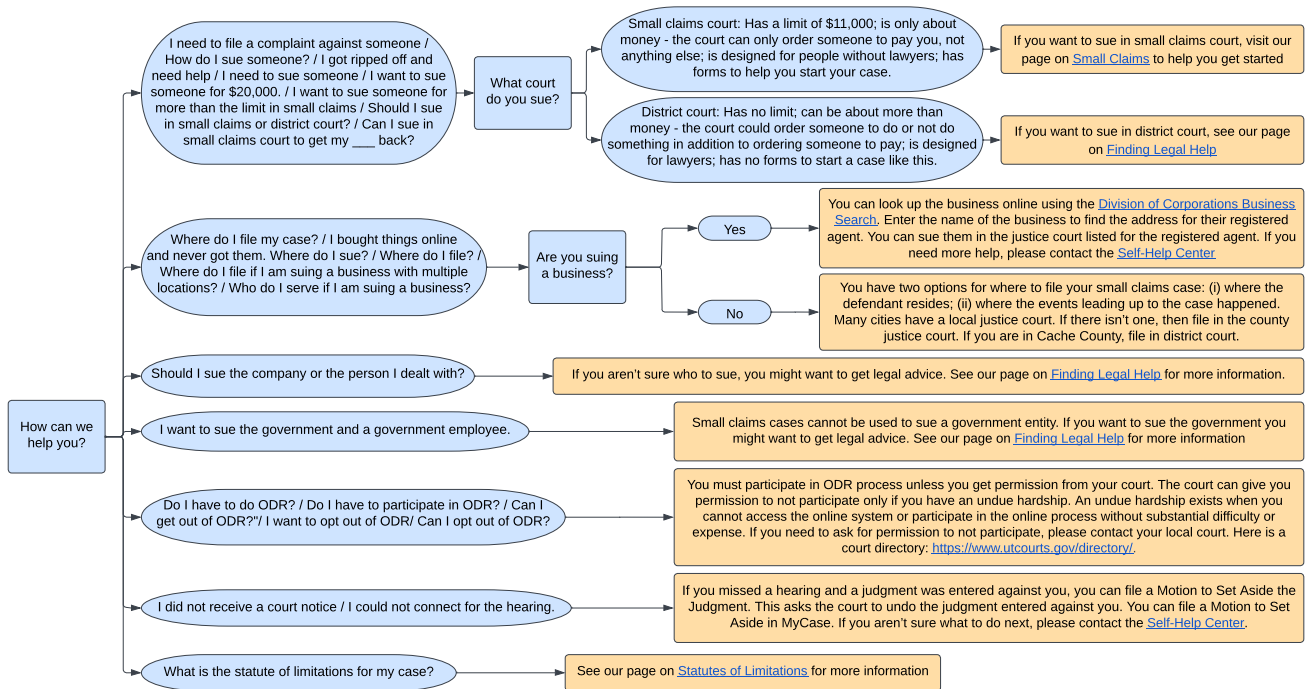


Figure 10: The flowchart with context for the small claims questionnaire.

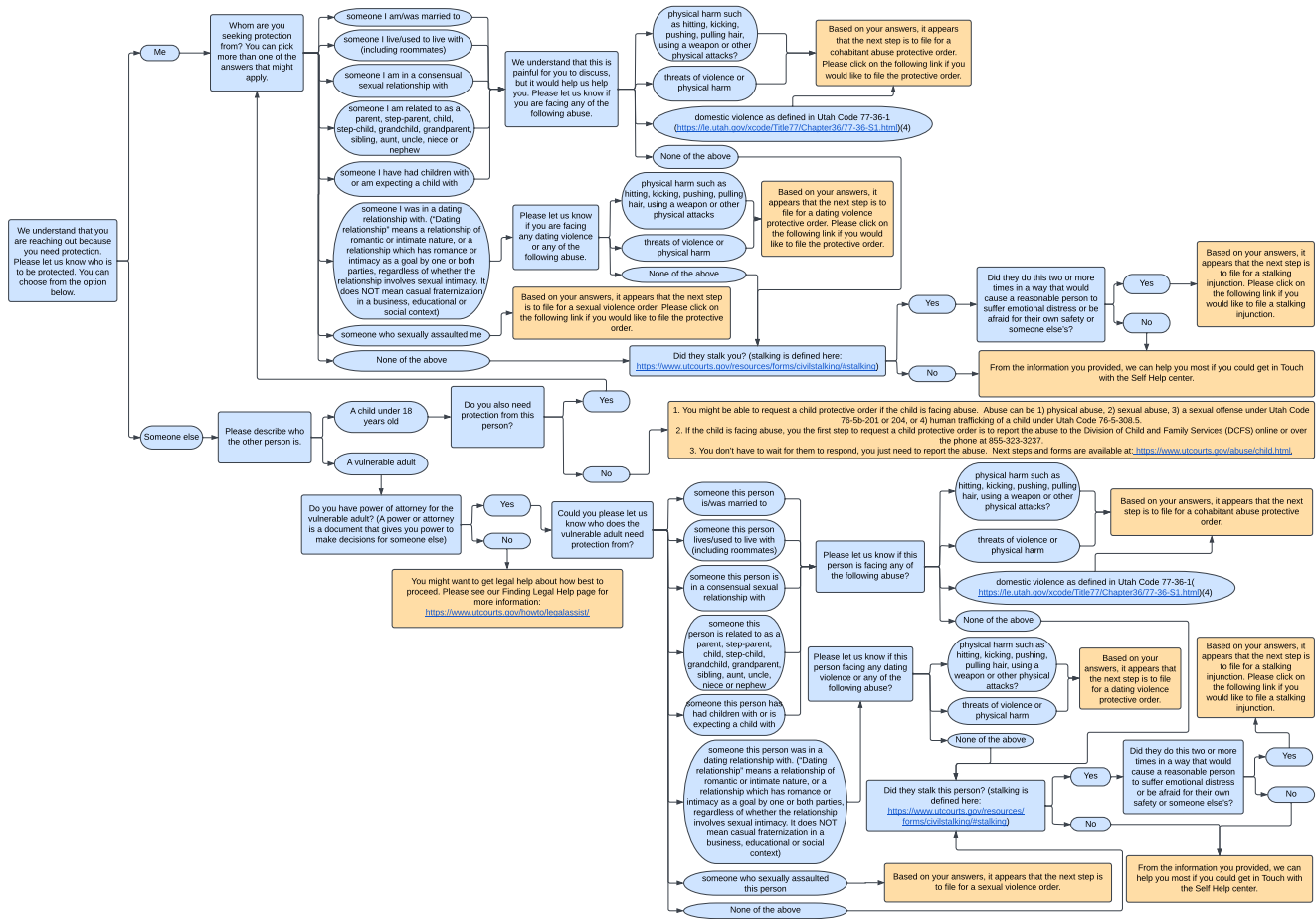


Figure 11: The flowchart with context for the protection questionnaire.
